Day 5: Saturday, Jul 16, Wolfville, NS, to Grand Pré to Annapolis Royal—Today we celebrate Acadian Days at Grand Pré. After passing the Melanson Homestead, enjoy lunch in Annapolis Royal and take a tour of this quaint seaside village. Then we depart on the ferry for our ride back to Saint John.
